It is further certified that the undersigned has read and is familiar with the premium list published in connection with this show and also the current NAPHA Show Rules & the Peruvian Horse Breed Standard and agrees to be bound by all of the rules and conditions, including but not limited to, those which discuss liability, risk, damage, injury, responsibility, and indemnity.

The undersigned also hereby agrees to hold harmless the boards and members of all approved regional clubs, the North American Peruvian Horse Association (NAPHA), the Peruvian Horse Association of Canada (PHAC), and the board, management, and employees of the Will Rogers Memorial Center for any injury or damages that may result from participation in the 2009 U.S. National Peruvian Horse Show.
